Cresline will repair or replace, free of charge, any such pipe or which has been installed in conformance with manufacturer's fittina recommendations and all local plumbing, fire and building code requirements and which, under normal use and service for the transmission of domestic water, proves defective in material or workmanship, as determined by Cresline, for as long as the original owner owns the property, provided the claimed defective pipe or fitting is promptly returned to Cresline with transportation charges prepaid within thirty (30) days of the discovery of such defect. If Cresline's inspection discloses no defect in material, workmanship, or design, then repair or replacement will be made at the customer's expense.

This Warranty shall not cover damage to pipe and fittings made of FlowGuard Gold<sup>®</sup> CPVC, caused by improper handling or installation, the use of chemicals or abrasives, the freezing of water in such pipe, compressed air or gas in such pipe, or the misuse, misapplication or improper maintenance or repair of such pipe. This Warranty is limited to the performance of Cresline FlowGuard Gold<sup>®</sup> CPVC as a material used to manufacture plumbing pipe and fittings, and does not extend to the workmanship of and/or design by your plumbing contractor or builder, or any items not manufactured by Cresline.
